## FIRST AMENDMENT TO CARDIFF GLEN SUBDIVISION IMPROVEMENTS AGREEMENT

This First Amendment to Cardiff Glen Subdivision Improvements Agreement is executed as of this \_\_\_\_ day of April, 2001, between the CITY OF GLENWOOD SPRINGS, COLORADO ("City") and STUDIO 3 LAND COMPANY, LLC, a Colorado limited liability company ("Developer"). It modifies the Cardiff Glen Subdivision Improvements Agreement ("SIA") dated June 22, 1999, and recorded June 24, 1999, Book 1136 at Page 905 in the records of the Clerk and Recorder of Garfield County, Colorado.

- 1. As provided for in Section 2 of the SIA, the Developer and the City are to amend the recorded SIA for each of the Phases two through five for the cost of specified Public Improvements and the security to be provided therefore. This First Amendment amends the SIA for Phase Two of Cardiff Glen.
- 2. Table One Phase One Public Improvements shall remain in place including security until such time as the Developer requests release from security for work completed. In addition to security held for Phase One Public Improvements, the Developer amends Table One to include Phase Two Public Improvements as follows:

- 3. Concurrently with execution of this First Amendment, Developer has submitted to the City a Letter of Credit for \$916,748.00, which the City has accepted, as security for completion of the Public Improvements for Phase 2 of Cardiff Glen.
- 4. EXHIBIT B Schedule of Phasing shall be replaced in its entirety with the attached EXHIBIT B AMENDMENT #1 Schedule of Phasing.
- 5. EXHIBIT C Engineering Cost Estimates for Phase Two Public Improvements shall be amended for Phase Two by the inclusion of the attached EXHIBIT C AMENDMENT #1 Engineering Cost Estimate for Phase Two Public Improvements.

- To the extent any letter of credit provided to the City to secure completion of Public Improvements for Cardiff Glen Subdivision is to expire prior to completion and acceptance of such public improvements, Developer agrees that it will secure a renewal letter of credit for the amount still secured prior to the expiration of the expiring letter of credit.
- 7. This Amendment may be executed in one or more counterparts which, when taken together shall constitute but one and the same Amendment.
